



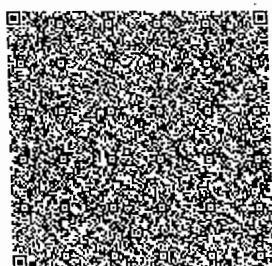

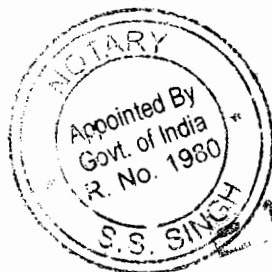



8. That the process (es)/work/job(s) on which the contract workers are to be deployed is/are not abolished by any Authority or board.

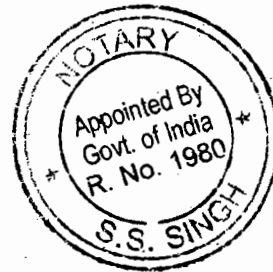
